 sharing your knowledge, experience and skills to help us to make a difference to the lives of the people with learning disabilities we support.



 being committed to helping the organisation get good results and put people with learning disabilities first in all decisions.



 understanding of the needs of people with a learning disability and/or autism and the issues and barriers they face.



<u>Responsibilities</u>



 To agree on and regularly monitor the Elfrida Society's plans and make sure it does what is says it will.





2. To help to set goals and evaluate performance against agreed targets.



3. To act in the best interests of the Elfrida Society's plans.



4. To safeguard the good name, ethos and values of the organisation.



5. To ensure the organisation doesn't waste money and has enough funds to keep running.



6. To help with the appointment of the Chief Executive Officer and monitor their performance.



7. To chair and/or attend events agreed by the Board of Trustees.

 one full day for a whole group meeting at a different location (we will make sure you can get there easily).



 Trustees might also want to join one of the board sub-committees which meet quarterly.



• Trustees will serve a three-year term to be eligible for re-appointment for one additional term.
